### 关于本指南

### 关于新西兰访客签证

如果您想作为游客访问新西兰、探亲访友或参加短期课程的学习,请使用访客签证。该签证只能在线申请。

您需要有足够的资金以维持您本人以及您申请中所包含的所有人在新西兰停留期间的生活,或 者有担保人为您提供经济支持。您不能持访客签证工作。



请注意,澳大利亚和某些国家的护照持有人在前来新西兰之前不必申请签证,但可能需要持有 NZeTA(新西兰电子旅行授权)。
